NEW BUSINESS

Provision of Menstrual Products

Ministerial Order was issued April 5, 2019 – All BC public schools will be required to provide free menstrual products for students in school washrooms by the end of 2019. Policy:

Menstrual products must be made available in school washrooms using delivery methods that:

- Are free of charge
- Protect privacy
- Are barrier free and easily accessible
- Are consistent in delivery and availability
- Are non-stigmatizing
- **Surrey Schools** completed installing dispenser units and acquiring start-up product inventory for all schools in the district by December 31, 2019.Project allowed for menstrual products to be made available in 3 washrooms in each elementary school.
- Sheree Elston to provide more information in next meeting about availability of menstrual products

Grade 7 Grad Committee:

- Grade 7 fundraising initiatives are not required to be approved by PAC, clarification to be provided to grade 7 teachers and fundraising committee by Sheree Elston.
- Fundraising efforts such as "Loonie Toss" require a registered gaming license. PAC must apply for this license. Gaming grants at risk if registration is not completed and a license is not obtained.

Notes from DPAC Summit

• Provincial growth impacting school capacities, communities are experiencing growth issues.

100,000 people expected to move to BC in 2023 (60% outside of country, 40% within Canada).

a. *DPAC Coalition has drafted and sent a letter to Premier David Eby asking for consideration including:

- Align housing policy and planning with school planning
- Restore life-cycle cost analysis for school facilities
- Provide timely and equitable access to education for students with disabilities
- Consent Curriculum Ministry of Education and Child Care released updated health guidelines and expanded curriculum improving how students are learning about consent. Concerns about students not feeling safe, and females being sexually harassed, including assaults occurring in some schools.
 SOGI (Sexual Orientation and Gender Identity), Anti-Racism and Mental Health. Discussions, and presentations in 2023. More info to follow as dates scheduled. Inclusivity, safe environments.

*January DPAC Meeting – Anti Racism Presentation

- Flu Shots/COVID Boosters BC Centre for Disease Control gave update on health and wellbeing of children and youth in BC. Spike of child admissions into hospitals. Encouraging everyone to get their flu and COVID boosters. Trustee Report
- Construction Phases: Semiahmoo Trail in planning phase
 Teacher experiences/burnout employee Wellness Survey launched
- **Teacher shortages** across the province and replacement process, growth rate has been a factor.
- **Racism** more work needs to be done to provide physical and emotional health and safety. Education is critical in addressing the issue of racism. BOE approved recommendations to strengthen antiracism efforts to goals and objectives that are adaptive, structural, systematic, strategic, and measurable.

Enrollment Update
