In conjunction with Surrey School's Safe School's policy, the Guildford Learning Centre has developed a Student Code of Conduct to ensure an **inclusive**, **safe and caring school**, where we all work together with cooperation and understanding.

CODE OF CONDUCT (2021-2022)

- 1. **Respect:** for the school environment, for personal property, and for each other regardless of race, religion, gender, age or sexual orientation; GLC is a LGBTQ+ safe, inclusive and positive space. All members are responsible for their words, decisions, and actions. Infractions will be dealt with appropriately.
- 2. **Bullying, Discrimination, Harassment, Violence:** GLC is a community free from behaviours that cause others harm, physically, psychologically and/or emotionally. Appropriate consequences will be applied to those who intentionally put the well-being of others in jeopardy.
- 3. **Drugs, Alcohol, Weapons, Replica Weapons**: being at school under the influence, in possession of drugs, alcohol, and/or weapons is unaccepatable. These types of behaviours may result in suspension, removal from the school and/or police involvement.
- 4. **Attendance:** a parent/guardian is required to contact the school to excuse all absences. **Unexcused absences are expected to be made up**. Appropriate strategies will be implemented to help address those who struggle with chronic absenteeism (Support from Student Services, etc.).
- 5. **Punctuality**: students are required to attend on time. Students arriving 30(+) minutes late, will be **required** to attend Friday School if the late arrival is **not** excused by a parent/guardian.
- 6. **Leaving School Property:** students are not permitted to leave the school property during the Morning or Afternoon Session, including the Nutrition Break. Students must have parent/guardian permission to leave school prior to dismissal.

7. Electronic Devices:

- a) Cellphones/other PD's: can be used to do research, document, collaborate and create. They are not to be used for gaming or social media/networking during instructional time, without teacher permission. Students not willing to comply may be asked to turn their phone in to the office and/or may be sent home. Students are welcome to listen to music; if the music is disruptive/interferes with learning, appropriate consequences will be implemented.
- **b) Computer/iPad usage:** school devices are to be used for school/educational related activities; they are not to be used for social networking or matters unrelated to school work.
- 8. **Dress Code:** students are asked to dress in a manner that is safe, respectful and considerate of others. Clothing with hateful, offensive and insensitive language, messaging, pictures or logos is not permitted.
- Scent Free/Tobacco Free: GLC is a scent free environment. Use of tobacco products, including vapes/electronic cigarettes, is prohibited on School District property. Violations will result in appropriate consequences.
