Every so often, I have students coming to me with concerns of things that others have posted on social media. Sometimes, these posts are serious enough (threatening, harming, bullying, harassment) to warrant significant action on our part. Other times, and most often, they are posts that may be mean, use bad language, cause drama within a group, or not the best choice of post. All of this posting is happening outside of school hours, but we all work together to make our community safe and kind. Many classes, especially in the intermediate grades, do learning units on social media use and digital citizenship. It is vital, however, that parents join us in this learning.

Did you know that popular sites such as Intragram and Snapchat have a minimum sign-up age of 13? Now I fully understand that many children have accounts at these sites before that age but we as parents need to have in depth knowledge of what our kids are doing on there.
